1	Call to Order 7:02PM
2	Report on Quorum: 18 required for quorum. 32 Voting members participating: 17 in-person attendees and 15 by-proxy attendees. See page 2 for full list.
3	Approval of Agenda: approved
4	Approval of 2023 minutes: Allen Lytwyn moved, Brian McCann seconded - approved
5	Business Arising from Minutes: Allan reported on the 2 items of Business Arising; indicating that the Board has a draft plan for washroom and bar renovations, has addressed financials through new revenues and lower costs and will work on the reserve management issue in 2025. Clarification regarding 2023, 2024 and potential future capital investments was provided.
6	President's Report: Allan reported: significant facility improvements (clubhouse furniture, court benches, court equipment), kudos to KTC sponsors, significant work on clubhouse lease negotiations (a document is in the hands of the property manager and a month-by-month lease is in place until the new lease agreement is finalized), shout-outs to staff and volunteers, appreciation for the membership and a very positive view of the club's performance and future outlook. Allan clarified that the current lease document is very similar to the original lease, however since Valhalla Cove does not utilize the clubhouse in the off-season, the agreement recommends changing the 60/40 cost sharing to 100/0 and at the request of Valhalla Cove a shorter lease term of 7 years.
7	Treasurer's Report: Lorena advised that the \$6,184 profit was the result of continued strong membership, new revenue sources, positive outcomes for existing revenues and judicious management of costs while maintaining great customer service. She discussed that prudent investments in KTC's facility were made and the Board will ensure funds are available at the point when the courts require resurfacing. Lorena provided a positive overview of the changing membership demographics which bodes well for future member recruitment and retention.
8	Manager report: McKenzie summarized the club's focus on customer service, member recruitment and retention and her work with the Head Pro to implement programs. She discussed several new ideas for 2025 including utilizing social media. She advised that her work to streamline league, tournament and program processes is saving time and anticipates requiring fewer hours in 2025.
9	Head Pro report: Pete summarized that he's continuing to fine-tune the tennis program offerings to suit the changing needs of members and has a plan to re-build junior program attendance. He heard feedback suggesting he expand the skill specific clinics (e.g.: groundstrokes, volleys, sport game psychology, etc.). He recognized the Assistant Pro – Olga Berdinskykh's role in delivering great programming for the club.
10	Election of 2025 Board of Directors: Wes indicated that 4 or 5 members put their name forward and he had discussions with each person to determine the nominee for the one Board opening. He recommended a 10 person Board, comprised of 9 returning Board members and 1 new. Motion to accept John Teillet/2 nd Brian McCann – passed.
11	Other business: <ul style="list-style-type: none"> • Two members suggested that the wage cost detail of each KTC staff person and the KTC Head Professional be provided in the financial statements. • Members provided positive feedback on club operations and their appreciation for the Board and KTC management, staff and tennis professionals.

2024 AGM – Business Arising and Board Response

- 1) Query: Two members suggested that the wage cost detail of each KTC staff person and the KTC Head Professional be provided in the financial statements.

Board Response: The Board decided not to publish KTC staff's confidential personal wage and contract remuneration details in the financial statements.

The Board has the following information for the membership:

- The Executive Team approves the wage and contract remuneration annually by reviewing Manitoba CPI and comparative wage rates.
- Working collaboratively, the Executive and the KTC management team strategically reduced overall wage costs by passing on additional administrative costs to the Pro and by reconfiguring the Manager role to a 4-day work week.

- 2) Comment: Members provided positive feedback on club operations and their appreciation for the Board and KTC tennis professionals, manager and staff.

Board Response: The Board directs the management of the club by placing the satisfaction of members and financial viability of the club as its highest priorities. The Board is confident in the delivery of its goals through the contributions of the Management Team (Head Pro, Assistant Pro and Manager) and staff (Customer Service Representative). The Board sincerely appreciates the positive feedback and will endeavor to continue to meet or exceed the expectations of club membership. Our goal is to be the best managed seasonal club in Winnipeg.

2025 PRESIDENT'S REPORT

I am pleased to report a very successful year for Kildonan Tennis Club. KTC's strategic goal to diversify its membership, modernize operations and offer a full slate of tennis programs is showing clear signs of success. I would like to offer my gratitude to our outstanding Management Team - Head Pro Peter Otto, Assistant Pro Olga Berdinskykh, and Manager McKenzie Trann, who ensure a great member experience for the KTC community throughout the tennis season.

The financial results for 2025 were strong. Key drivers were member participation in the CLAIM A BENCH – Leave a Legacy sponsorship program, member's corporate sponsorships, strong membership numbers, and strategic cost savings. We are very thankful for members' generosity and loyalty to KTC, which only serves to highlight the friendly and welcoming atmosphere at the club. The 2025 financial result, along with a 50% cost sharing grant from the City of Winnipeg, has paved the way for a deck repair and pergola build project to go ahead next season. The project will commence in Spring 2026 and will aim to be completed prior to clubhouse opening day. The Board is also exploring a project to refurbish the clubhouse. Because the application for grant support was declined, this project is on hold; however, the Board will continue to apply for grants to make this project feasible in the future.

In 2024/25, the Board continued negotiations to renew the clubhouse lease. For background, KTC owns the parcel of land upon which the tennis courts and parking lot are located; however, for the clubhouse, KTC has a 25-year lease, which expired October 31, 2023. The Board of KTC and the Executive Director(s) of Donwood Manor acting on behalf of Valhalla Cove have had fruitful talks since commencing discussion in January, 2021; changes in personnel over the years has slowed progress to date. At this time, the KTC-prepared draft lease is being worked on by the Executive Director and the Valhalla Residents group. Once their feedback is received, negotiations will continue. In the meantime, KTC has agreement from the Executive Director to keep the existing lease terms in effect until a new agreement is signed.

In closing, many thanks to all the Board member volunteers, with kudos to Allan McElroy, Ed Gardy and Lorena Trann who spent many hours behind the scenes working on negotiating the lease, facility maintenance and finances, respectively. I would also like to thank departing Board members Wayne Jackiew and Marek Chomicki for their valuable contributions to the Board.

On behalf of the Board and staff – Thank You to all KTC members! You make KTC a welcoming and fun place to play tennis. I am very glad to have made the decision to join the club in 2020 and it's had a very positive impact for me personally. I'm humbled to be a small part of the club and I will look to continue to steward the club toward the future and honour those who have given, and continue to give, their time and energy to making KTC the wonderful place it is. We look forward to serving you again in 2026!

2025 TREASURER'S REPORT

Kildonan Tennis Club is in sound financial condition with a balance of \$500 in the operating account and \$139,045 in the reserve funds.

In 2025, the Board approved a new reserve policy: Hold a minimum principal amount of \$125,000 in the Perpetuity Account. Annually, deposit all interest (roughly \$5,000) from the minimum Perpetuity principal balance, and the net profit from the Operating Account (annual goal \$5,000) into the Court Renewal Fund.

The sponsorship programs and changes to the pro and management contracts contributed positively to the financial strength of the club.

Operating Fund:

The 2025 net profit was \$11,800 (2024, \$6,184). After transferring \$11,709 to the reserves, the operating bank account balance is \$500 (2024, \$409) which is sufficient to cover off-season bill payments. Highlights from the Club's operating income are:

- Membership revenue was \$52,930 (2024, \$53,839); 177 adult members (2024, 182).
- Net income from the Clubhouse operation was \$4,298 (2024, \$4,370).
- Canada Summer Jobs Grant revenue was \$4,424 for one staff (2024, \$4,284, one staff).
- Sponsorship Revenue was \$8,400 (2024, \$5,700)
- Total expenses were \$66,964 (2024, \$68,645), with the reduction in costs attributed to lower wage costs, offset by higher phone/internet/web costs.

Reserves:

KTC retains two reserves. The Perpetuity Fund (2025 balance: \$125,000, 2024 balance: \$118,291) is in place to hold a minimum principal amount of \$125,000 ensuring the long-term financial stability of the Club. The Court Renewal Fund (2025 balance: \$14,045, 2024 balance: \$8,461) is a maintenance fund.

Deposits into the Perpetuity Fund were capped at \$6,710 (\$5,162 interest, \$1,548 transfer from operating profit) to achieve the \$125,000 minimum principal amount. The Court Renewal Fund increased by \$5,584 after the transfer from operating profit & fundraising monies of \$4,761 and \$5,400 respectively, offset by payments in the amount of \$4,624 for lease and capital costs (legal fees, deck repair/pergola build project deposit, AED, miscellaneous clubhouse items) and recording interest of \$47. The Deck Repair/Pergola Build project cost is approximately \$17,000 and will proceed in spring, 2026. KTC will pay 50% of the full cost of the project, with the City of Winnipeg providing the remaining 50% under their Community Incentive Grant Program.

KTC's financial outlook is positive. The 2026 budget predicts an operating net profit of at least \$5,000 and perpetuity reserve interest earnings of roughly \$5,000. KTC holds sufficient funds to support the 2026 Deck Repair/Pergola Build project.

NOTES TO THE FINANCIAL STATEMENTS
OCTOBER 31, 2025

1 Purpose of the Organization

Kildonan Tennis Club Inc. (the "Organization") is a Manitoba organization operating as a private tennis club. The Organization is incorporated under The Corporations Act (Manitoba) as a not-for-profit corporation.

2 Investments

All Court Renewal Fund and Perpetuity Fund investments (the "Reserves") are under the control of the Board of Directors. Funds are invested to a maximum of 5 years with the goal to preserve invested capital.

a) Court Renewal Fund:

The purpose of this fund is to provide sufficient funds to keep the courts, equipment, grounds and clubhouse facilities in good condition and to cover extraordinary expenses. Annual contributions are comprised of interest earnings from the Perpetuity and Court Renewal Funds and net profit from the Operating Fund.

b) Perpetuity Fund:

The Perpetuity Fund was created in 1988 with a \$25,000 deposit, with the purpose of holding funds for the long-term financial stability of the Club. In 2025, the Board approved a new funding policy, which now ensures that the Perpetuity Fund maintains a minimum principal balance of \$125,000. All interest proceeds generated by the fund's principal balance are transferred to the Court Renewal Fund.

8 Transfers from Operating Fund to the Reserves

In accordance with Note 2, the following inter-fund transfers were recorded during the year:

- \$1,548 was transferred from the Operating Fund to the Perpetuity Fund to comply with the new Reserve Policy, bringing the Perpetuity Fund to a closing balance of \$125,000;
- \$5,400 of proceeds from the Claim a Bench - Leave a Legacy campaign were transferred from the Operating Fund to the Court Renewal Fund; and
- \$4,761 of remaining net operating income was transferred from the Operating Fund to the Court Renewal Fund to maintain a balance of \$500 in the Operating Fund.


2025 MANAGEMENT'S REPORT

Kildonan Tennis Club endeavours to be the best managed seasonal tennis club in Winnipeg. We strive to meet the evolving needs of the membership group. We actively encourage membership growth, community, and fellowship. KTC endeavours to enhance membership satisfaction with club programs and operations by seeking out and trying new ideas and by making constant improvements to the website, on-line services and clubhouse operations. This report provides information on membership and programming trends and on member recruitment and retention.

MEMBERSHIP REPORT

2025 KTC Membership was solid at 177 (in 2020 and prior years, membership hovered around 140-150, an all-time high of 195 was achieved in 2022). KTC's goal is to grow to a 200 person membership. The on-line membership system implemented in 2020 has assisted with the growth and evolution of the club. The additional goal to diversify the membership is progressing, illustrated by the following statistics:

- The average age dropped from 51 in 2020 to 46 in 2025
- The percentage of female members grew from 27% in 2020 to 32% in 2025
- The percentage of younger members (ages 18-44) grew from 28% in 2020 to 44% in 2025,
- Our valued long-standing membership base has been retained
- Roughly 1/3 of the membership have been members for decades.




TENNIS PROGRAM OFFERINGS AND REGISTRATIONS REPORT

KTC offers a multitude of programs, including free opening season offerings, leagues, tournaments, lessons, and clinics. Each year's results are analysed to help inform program offerings for the upcoming year. KTC now has 5 years of full programming experience and information; at this point, the line-up of programs is working very well and requires only slight tweaking annually.

Free Programming

KTC begins each year with an assortment of complimentary clinics (mixers, specialty clinics, feeding frenzy), and events (opening party, closing party).



Leagues, Hitting Clubs and Ball Machine




The singles and doubles leagues are fully subscribed annually at 40 and 24 players respectively. The Hitting Club membership is roughly 15-20 players, the Ball Machine is used by 17-20 players 40-80 court hours.

Otto Tennis Academy

In 2025, the Otto Tennis Academy for elite junior players held twenty-four 3-hour sessions for a group of 12 players; this is up significantly from 2024 (the first year of the program). Under the guidance of KTC pros, the athletes worked on tennis skills and fitness training.


Popular and Established Clinics and Programs


Specialty and Fledgling Clinics

Member feedback resulted in the creation in 2025 of a Groundstroke Clinic, Volley Clinic and Serve/Return clinic, each of which were offered a couple times this season. These programs will all be held more frequently in 2026 as participation continues to increase. Also included in this grouping are the Adult Intermediate Group Lesson, Adult Day Camp and Cardio Clinic; newer programs that are starting to attract more participation. Below is a breakdown of the total participants and number of all Specialty/Fledgling clinics offered – these clinics are definitely becoming popular among club members.




Private Lessons for Members and Non-Members

KTC offers private lessons for members and non-members with non-members remitting a court fee. Each year, the split between member and non-member participation varies, in 2025 40 members and 27 non-members took lessons, members accounted for 71 percent of the total private lesson hours. The Assistant Pro has been delegated the responsibility for all new lesson requests (2025, 23 new clients; 2024, 29 new clients) and delivers the majority of lesson hours.

KTC MANAGEMENT, MEMBER EXPERIENCE and MEMBER RECRUITMENT AND RETENTION

KTC strives to provide the best customer service possible to generate a positive atmosphere among members. We answer queries 24/7, responding as fast as possible. Our website provides program information well in advance of the season start date and is constantly updated throughout the season, giving members and the general public plenty of time to contemplate program sign ups. We want to be the best managed tennis club in Winnipeg and are proud of our customer-based operating methods.

KTC continues to attract new members through the website, via referrals, and by actively pursuing potential new members through our signature programs - the One Day Pass, 3 Week Trial membership, 30 Day Membership, the Late Season membership deal, and the Refer and Receive program. Two business partnerships (Orangetheory and StretchLab) are used to increase KTC's exposure to potential new members.

To ensure new members feel welcome at the club, each new or potential member is contacted to personally welcome them to the club and to establish a contact point at KTC. Free Hitting Clubs and various optional clinics are offered to help grow the membership, foster member satisfaction, and build a community within our membership. Our goal is to achieve a 200 person membership count.

CLUBHOUSE/PATIO HOURS and SERVICES:

The Clubhouse offers snacks, beverages, alcoholic beverages, tennis balls, and Pro Shop services. Open May 10th to September 6th, Clubhouse daily hours coincide with peak customer activity.
